CORPUS FUND, INVESTMENTS, ACCOUNTS ETC.:



- a) The Trustee shall have power to spend the Income of the Trust for any of its object and also to accumulate the income for any specific purpose or purposes subject to the conditions contained in the deed and in compliance to the relevance provisions of the Income tax Act.
- b) The Trustee shall be entitled to spend from the corpus fund, or the general funds of the Trust for the purposes and object of the Trust.
- c) The surplus fund of the Trust which are to be accumulated shall be kept invested in securities as per the provisions of section 11(5) of R.W.S. 13(1)(d) of the Income tax act applicable to Charitable Trust for the time being in force.

- b) The Trustee shall induct additional 5 numbers as members to the Board of Trustees as and when required, irrespective of caste, religion and sex etc., who shall hold office for 3 years period.
- c) The Board shall meet once in two month, and as and when required on the requisition by a majority of the members of the Board of Trustees in writing
- d) The quorum for the meeting shall not be less than three (3)
- e) The Managing Trustee (Director) shall be the Chairman of the Meeting and in his absence the Chairman shall be elected by the members present.
- f) In the absence of unanimous decision, the vote of the majority shall prevail in case of equal decision the chairman of the meeting shall have casting vote.
- g) The Board of Trustees shall be competent to pass any resolution by circulation and such resolutions are to be ratified at the subsequent meeting of the Board of Trustees.
- h) A Member of Board of Trustees can be removed only on the approval of majority of the Board of Trustees.
- i) The Board is entitled to do all such acts to carry out the objects of the Trust.

7. POWER OF THE MANAGING TRUSTEE :-

The Managing Trustee (Director) is empowered:

- a) To execute, sign, acknowledge and effect and register all deeds, agreements and writing and to give official discharge on behalf of the Trust.
- b) To institute, conduct, defend, compound, withdraw, compromise, refer to arbitration or abandon any legal or other proceedings, claim against the trust or Trustees or against the employees concerning the affairs of the Trust, and to sign and verify vakalaths, statements affidavits and other proceedings before all courts and Government authorities

- c) To appoint from time to time and at any time to suspend, dismiss, remove or discharge any person under the control of the Trust including clerks, accountants and other employees with such powers and duties as the Board of Trustees think proper.
 - d) To maintain the minutes of the proceeding of the Board of Trustees and render proper accounts for the funds and assets of the Trust.
 - e) To draw, make, accept, endorse, discount, negotiate execute, cheques, bills of exchange and other negotiable instruments and to receive donations from public and member of the Board of Trustees.
 - f) To open, operate and close accounts with banks and other approved financial institutions and to pay and draw funds from such accounts and otherwise deal with the same jointly with one other member of the Board of Trustees.
 - g) To hold the seal of the Trust in custody.
 - h) Subject to ratification by the Board of Trustees it shall however be competent for the Managing Trustee to nominate one among the above trustees who shall perform any other functions in the clauses (a) to (g)
 - i) To do such other acts and deeds consistent with the powers contained herein and such other acts authorized by the Board or Trustees.

8. LIQUIDATION :-

- a) The Trust shall be irrevocable.
 - b) In the unfortunate event of the Trust being liquidated due to unforeseen circumstances in the future, the entire trust funds shall be realized and first be used for payment of liabilities of the Trust. The assets left, if any, shall be transferred to a similar trust or charitable institution as approved by a majority of the Trustees, whose objects are similar to those of this trust and which enjoys recognition U/s. 80G of the I.T. Act.
 - c) The trust will not function in the nature of conclusion of a business activity and not for the purpose of profit.


